Postgraduate Admissions Statement for Public Health MSc



This Admissions Statement applies to applications submitted for entry to the programme between 18 September 2024 and 17 September 2025.

Admissions criteria

Academic and English language requirements

The academic and English language requirements for this programme are displayed on the <u>Postgraduate</u> <u>Prospectus.</u>

Non-standard applications

We welcome applications from those with non-standard qualifications who can demonstrate knowledge, experience and skills developed in the workplace, or elsewhere, relevant to the programme of study. Please use your personal statement to provide further details.

Application process

Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our <u>guidance for online applications page</u>.

Applications will not be considered until **all** required documents have been uploaded.

Required and optional documents

References: Required

One academic reference will be required as part of the application process. Professional references may be accepted if you graduated more than two years ago, or if professional experience is relevant to the application.

References should comply with our standard requirements outlined on our guidance pages.

Degree certificate(s) and academic transcripts: Required

From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on <u>our guidance pages</u>.

Personal statement: Optional

Personal statements are not required for this programme as they do not form part of the routine application assessment process. However, where an applicant is slightly below the typical entry requirements we may use the personal statement, if provided, to look for additional context and detail about relevant work experience and achievements. Applicants are therefore welcome to submit a personal statement, as an additional document, to support their application if they wish to do so.

English language certificates/other evidence: Required

Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the <u>University English Language Requirements Policy</u>

Curriculum Vitae (CV): Optional

CVs might include details of other relevant work experience and qualifications to support an application.

GCSE certificate or equivalent: Required

Applicants must provide evidence of numeracy skills e.g. a minimum of GCSE Mathematics at grade B, or equivalent evidence of numeracy from undergraduate degree.

Selection process

Assessment of applications

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy</u> Once a complete application has been submitted with all required supporting documents, it is considered by at least two members of staff using the following criteria:

- Performance in undergraduate degree
- English language ability (where applicable)
- References
- GCSE certificate or equivalent

Interviews

Interviews do not form part of the admissions process.

Decisions

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

Offers

Offers will typically be made in line with the academic requirements set out above.

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.

Deferrals

Requests to defer the year of entry must be submitted via the applicant portal. Requests to defer should be submitted at the earliest opportunity so that it can be reviewed by the admissions team. We cannot guarantee that requests will be granted.

Results deadline

Applicants who receive a conditional offer will be required to submit all final results to meet their offer conditions by the date noted in their offer letter. Offer holders who are unable to provide their final results by this date should email **choosebristol-pg@bristol.ac.uk** to notify the team as soon as possible.

Additional information

Extenuating circumstances

If your education has been significantly disrupted through health or personal problems, disability or specific difficulties within your studies, you can submit an <u>extenuating circumstances</u> form as part of your application.

Academic Technology Approval Scheme (ATAS)

An ATAS certificate is not required for this programme.

Visa

Fees and Deposits

Fees

Annual tuition fee is available on the relevant prospectus entry for this programme.

Deposits

International self-funded students accepting a place on a taught postgraduate programme are required to pay a deposit of £2000. The deposit is non-transferable and non-refundable except under the circumstances outlined in the <u>International Deposits Refund Policy</u>.

Sponsored Students
