# **Application process**

## Online application form

Applicants should complete the online application form, uploading all required documents directly. Further information is available on our guidance for online applications page

Applicants should ensure agreed support from proposed academic supervisors within the School/University is secured prior to submitting their formal application. Supervisor details can be found <a href="here">here</a>. Applications without prior agreed supervisory support will not be considered unless in exceptional circumstances.

Applications will not be considered until **all** required documents have been uploaded.

## Required and optional documents

# **References: Required**

We require two academic references. References should comply with our standard requirements outlined on <u>our guidance pages</u>.

# Degree certificate(s) and academic transcripts: Required

From first and subsequent degrees. Degree certificates and transcripts should comply with our standard requirements outlined on our guidance pages.

Personal statement: Required

(Word count: 1300 words)

Personal statements should highlight the motivation for applying for the course, the School, and any relevant experience and/or skills.

## English language certificates/other evidence: Required

Evidence of meeting the English language profile as stated on the <u>Postgraduate Prospectus</u> and specified by the <u>University English Language Requirements Policy</u>. The English Language Profile required for Human Geography is Profile D.

## Curriculum Vitae (CV): Required

CVs can include details of other relevant work experience and qualifications to support an application.

# **Research Statement: Required**

(Word count: 1300 words)

The primary requirement for the research statement is to define and situate your proposed research and your research project within an academic/disciplinary context. You should remember that people in the academic community are the primary audience/readership for postgraduate research. This means that you will need to identify:

- 1. The research questions or problems that you intend to address;
- 2. The research context for your project/programme of work;
- 3. The methods you think you will use to pursue the key questions.

## **Optional Documents**

#### **Research Training Statement**

Applicants are welcome to provide details of any relevant qualifications or training required to assist with their application.

# **Selection process**

## **Assessment of applications**

All applicants are considered in line with the University's <u>Admissions Principles and Procedures Policy.</u> Once a complete application has been submitted with all required supporting documents, it is usually considered by at least two members of staff.

### **Interviews**

Candidates may be invited to visit the School of Geographical Sciences to meet potential supervisors and/or attend an interview as part of the selection process. Interviews usually last approximately 30 minutes. The purpose of the interview is to assess whether the applicant has the necessary skills and capabilities to pursue the chosen postgraduate programme, and whether the programme is appropriate to the applicant's interests and aspirations. Interviewees are assessed on: their academic achievement; research potential; fit to the project and strengths of the school; the strength of their references; and, their interview performance.

Interviewees based overseas will normally be interviewed online.

#### **Decisions**

Applicants will be notified by email when a decision has been made and decision letters will be available to view and print by logging into the application portal. If there is a deadline by which applicants must accept an offer of admission or pay a deposit, this will be stated in the offer letter.

## Offers

Offers made may be conditional or unconditional. An unconditional offer will be made to applicants who have already met the conditions and provided evidence that conditions have been met. Where academic or language requirements have not yet been fulfilled, applicants will receive a conditional offer outlining the requirements that must be met.
